



Poppies/ Music for Families: Sound Beginnings Policies and Procedures The Music Garden, LLC

Please initial the following items stating that you have read and agree to the policies and terms.

Tuition is as follows, per student; 1 semester payment, or 5 equal monthly payments. There are 15 lessons per semester. I understand that all tuition payments, my registration fee, and materials fees are non-refundable. I understand that I will not receive a tuition refund for missed classes or for discontinuing the program before the end of the semester. **The full 5 months' tuition is due even if I choose to discontinue the program early.** In case of unexpected hardships, I will notify the teacher ASAP.

I have reviewed the studio calendar and agree to the dates on the calendar. In the event class must be canceled due to inclement weather or to the teacher being ill, every effort will be made to offer a make-up lesson, but this is not guaranteed. If we are absent, and the teacher has excused the absence (ill or family emergency), I may ask permission for us to attend another class that week. This is not guaranteed due to other classes being at capacity.

I agree to read the parent texts and emails and will assist my child in repeating the activities at home, in an effort to maximize the benefits of the program.

I grant permission to The Music Garden, LLC to use photographs and/or video of me and/or my child for use on The Music Garden website, email newsletters, Facebook page, and other social media. I hereby waive any right to inspect or approve the finished photographs or electronic matter that may be used in conjunction with them now or in the future, whether that use is known or unknown to me. I waive any right to royalties or other compensation on arising from or related to the use of the image. I maintain the right to request the discontinuation of any image.

I will arrive no earlier than 5 minutes before class. I understand I may enter the studio when the classroom is empty prior to class and invited to enter by the teacher (I will not enter while another class is in session)

No gum, candy, food, diaper bags or toys are allowed in the classroom. Shoes are to be removed at the door. Hand sanitizer should be used at the beginning and end of class. I understand that masks are highly encouraged for all unvaccinated individuals 5 years and older and that **mask policies are subject to change based on Dept. of Public Health recommendations - check current posted requirements.** The Music Garden will not assume liability for Covid-19 related illness. No running allowed in the studio or in the building hallways and stairwells.

Siblings and friends may not attend class without special permission from the teacher.

If we are going to miss class, I will notify the teacher ASAP by either sending an email, sending a text, or leaving a voicemail.

Due to the physical nature of this program, by registering in the program, I, the parent or the legal guardian, accept full financial liability for any accident or injury that could possibly happen to my child, myself, or any guest accompanying me, while in The Music Garden, or on the premises.
